CANADA FEDERAL START-UP PROGRAM


The Start-Up Visa Program is a Residency by Investment pathway created to attract innovative entrepreneurs from across the globe who can establish businesses in Canada that are forward-thinking, generate employment for Canadians, and compete internationally. This federal immigration pathway offers permanent residency (PR) to qualified foreign entrepreneurs who are able to: develop innovative ventures in Canada, create jobs for Canadians, and operate at a global competitive level.

Successful applicants are granted Canadian permanent residency for themselves and their eligible family members, with the opportunity to apply for Canadian citizenship once all residency requirements are fulfilled.

ELIGIBILITY REQUIREMENTS:

- Investors must possess either Managerial or business experience
- ✓ Above 18 years of age, but must be less than 22 years for dependents
- Must be in good health.
- No criminal records.
- Test of English CLB Level 5
- The applicant must have a qualifying business (innovative, scalable, and capable of creating Canadian jobs).
- Must secure a letter of support from a designated Canadian organization such as a venture capital fund, angel investor group, or business incubator.
- Must meet language proficiency requirements (English or French).
- Must have sufficient settlement funds to support themselves and their family upon arrival in Canada.





PROGRAM PURPOSE:

To grant permanent residency to foreign entrepreneurs who establish qualifying start-ups in Canada.

18 - 24 Months

\$200,000 (Excludes Associated Fees)

After 5 Years
